The year 2010 again witnessed a number of fallen soldiers, and again, these have been remembered at monthly Board meetings. According to Media releases, these sacrifices have not been without some gains in Canada's efforts to assist Afghanistan in rebuilding itself as a more modern, open society. Much remains to be done. Many will cheer the transition of Canada's role to one of training the Afghan military and police, but even that comes with danger to our troops.

It is encouraging that year by year the number of Calgarians attending the Remembrance Day Services continues to grow. It is estimated that at the Military Museums Service alone there were between 12,000 and 15,000 in attendance. Each year requires additional efforts to make the service audible to the growing size of the crowd.

RAUSI (the Institute) and the foundation have made sizable donations to the Soldiers Memorial Wall (to be opened this Spring), to the Veterans Food Bank, to the Glenrose Hospital rehab unit in Edmonton, and other donations which recall both the sacrifices and the need to assist those who return home with severe wounds: physical, social or mental.

The work of both the Institute and the Foundation is enhanced by the generous donations from members of the Institute and the community in general. We do need your help, both in continuing your donations and in telling friends, neighbours and colleagues about the opportunities of membership and support. One way to help is to take part in the "Loops for the Troops" run on Father's Day or to sponsor someone who is participating in the Run. There are even opportunities to assist with the work of organizing and running the event.

BURSARY NEWS

The Wing Commander Don Freeman Memorial Bursary
and the Queen Elizabeth II Golden Jubilee Bursary Report for 2009 - 2010

The Royal Alberta United Services Institute annually offers two Bursaries for post secondary study. Each bursary is worth \$5,000. Criteria include level of need, probability of scholastic success, military service (e.g. Cadets, Reserves), and community service.

The Bursaries are open to descendants of RAUSI members, and those serving in some military capacity. Applicants must provide proof of actual enrollment in a post secondary institution. The 2010 RAUSI bursaries amounts were reviewed and increased from \$1,000 to \$ 5,000 each.

Thirteen applications were received by the end of May 2010. A review panel was struck and reviewed all applications. The two top candidates that were singled out were Mr. Skipton Jelskey , Queen Elizabeth II Golden Jubilee Bursary winner and Mr. Sadiq Valliani, Wing Commander Don Freeman Memorial winner. These two individuals, beside being full time students, had extra curricular activities as both were outstanding members of a cadet corps. The cheques were presented to the winners during one of our Monthly Luncheons, along with a one year membership with the Institute.

In 1939 a senior NCO of the RCA Battery in Lethbridge, having heard that the Calgary Highlanders were being mobilized for an early move to UK, departed for Calgary and enlisted in the soon to be active Regiment and was almost immediately charged with desertion. Brought before the CO, Lt Col J. Fred 'GOD' Scott, he explained himself and the case was dismissed. The RSM, Mr. Stanley (formerly Captain in the Calgary Regiment) immediately collared him to be the Orderly Sergeant that very day. The "deserter" was later Commanding Officer and Honourary Lieutenant Colonel of the Calgary Highlanders, a member of the Order of Canada, President of the RAUSI and City of Calgary Alderman, LtCol Mark Tennant, CM, OstJ, ED, CD



THE CALGARY SOLDIER'S MEMORIAL

The Calgary Soldiers' Memorial will commemorate those killed in times of war from Calgary's Army Reserve Regiments and the units that they perpetuate. This will include: The King's Own Calgary Regiment (KOCR), The Calgary Highlanders (Calg Highrs), 41 Combat Engineer Regiment (41 CER), 746 (Calgary) Communications Squadron, 14 (Calgary) Service Battalion (14 Svc Bn) and 15 (Calgary) Field Ambulance.

The memorial will be located on Memorial Dr., just west of 10th St. along the Bow River. It will overlook Mewata Armoury where many of these soldiers set out from to serve King/Queen and Country. The memorial will be a permanent memorial to soldiers who have made the supreme sacrifice serving their country and will list the names of all of those soldiers killed on active service during World War 1, World War 2 and the recent losses in Afghanistan.

The Memorial is being funded through the generosity of Government, Corporations and Individuals. In particular, The City of Calgary has funded a significant portion of this Memorial through their Legacy Parks Programme in conjunction with the Memorial Drive redevelopment. RAUSI graciously contributed \$25 000 to the project which was a substantial part of the fundraising. The total cost of design and construction of the Memorial will be close to \$900 000. The Memorial will be unveiled on the 9th of April 2011 ~ The 94th Anniversary of the Battle of Vimy Ridge.



In total, over 3000 names will be listed on large stone tablets that resemble the Commonwealth War Graves markers that the soldiers lay under around the world. Cap Badges of the respective Regiments will emblazon the top of each stone with the names listed below. Spot lights will keep the Memorial lit at night and a viewing platform will allow visitors to look across towards Mewata Armoury.

CADETS IN 2010

An outstanding future RMO

For many years, the final parade for the Royal Canadian Army Cadets' Leadership and Challenge course, at the Banff National Army Cadet Camp, until 1999, and now at the Rocky Mountain National Army Cadet Summer Training Centre north of Cochrane, has been held in blazing sunshine or torrential rain. The 2010 final parade was different, thanks to forest fires in British Columbia. Parade day was chilly and visibility was reduced; however, this

did not reduce the smartness of the Cadets and the parade. It is delightful to see the cadets standing proudly in their regimental accoutrements, badges, kilts and other unit identifiers which are a key to the future of the Army Cadet movement.

The Reviewing Officer was the Commander of LFWA, Brigadier-General P.F. Wynnyk, OMM, CD; a RAUSI member, son of the late Captain Walter Wynnyk, CD who was for many decades a key figure in the Army Cadet world in Alberta. General Wynnyk's military career started when he joined the 20th Field Regt Royal Canadian Army Cadet Corps, (no 2561), in Breton, Alberta, when the present Commander of the Rocky Mountain Camp, LCol Al Bratland was Corps Commanding Officer.

During the presentation of the well deserved awards for sub-unit and individual achievements, General Wynnyk joined with RAUSI Past President Major (ret'd) Dick Westbury, CD, (on behalf of the President, LCol W Schultz, CD,) in presenting the RAUSI Trophy, awarded annually since 1967, to the Outstanding British Exchange Cadet.

This trophy was first presented in 1967 by the Alberta United Service Institute as a Canadian Centennial project, to commemorate the CANLOAN Program of World War Two. The CANLOAN Program provided over seven-hundred trained Canadian officers to the British Army, who were short of officers due to casualties.

This year's recipient, Cadet Sergeant Sam Bourke, is a member of the Magdalene College School (Oxford) Combined Cadet Force Contingent; who wears the badges of the Royal Logistics Corps (successors to the RASC and RCT).

There was a very effective Cadet Corps CO who invited the Lieutenant Governor to inspect his growing unit. Very wisely he posted a cadet to hold a parking spot for His Honour's vehicle. When a rather old car driven by a nice old gentleman sought to use the spot he was challenged by the young sentry but was eventually allowed to use the spot when he explained that HE was the Lieutenant Governor. This was Dr. Grant MacEwan. This same cadet Corps CO later invited the Mayor of Calgary to visit his Corps. While the Mayor was waiting in the Mess for the CO, a future RAUSI President, who was then a serving Major General, happened to 'pop into the mess to buy a cigar', met the Mayor and chatted with him. The General felt HE SHOULD HAVE been advised that the Mayor would be visiting HIS mess. The debriefing lasted until 3:00 a.m.

Air Cadet Squadron Spearheads lifesaving efforts in partnership with RAUSI

Cadet Flight Corporal Mark Novak of the 604 "Moose" Royal Canadian Air Cadet Squadron spearheaded a fundraising campaign to purchase an Automated External Defibrillator (AED) for Mewata Armoury and RAUSI stepped up to the plate in a big way!

AED's have been proven to be much more effective at saving lives than CPR alone, and are designed for easy use even by the lay-person. Public places like Mewata Armoury with its multiple user groups and public functions is an ideal place for AED's to be on hand. About 40,000 Canadians experience cardiac arrest every year. That's about one every 12 minutes. Defibrillation improves survival rates by up to 30% if delivered within the first few minutes, and making them accessible to the public has the potential to save thousands of lives.

FCpl Novak learned this while attending his St John Ambulance Standard First Aid/CPR/AED certification. He's seen AED's in public places like his own school, the airport and the Saddledome - and he wondered why a place like Mewata Armoury didn't have one. So, he launched a campaign to raise the funds to purchase one and RAUSI stepped up with \$2500.00 - more than enough to buy one and establish it in an accessible location on the parade square.

The Membership Committee was formed in order to focus attention on maintaining current RAUSI Membership, increasing the membership base and identify like-minded individuals and organizations and invite them to join. The Institute is open to new members who may be currently serving in or retired from the Canadian Forces. However, membership is not limited to having military service, individuals and groups may join if they share the same values as the Institute regardless of military service. The Institute is very proud to include the senior leadership team of the Calgary Police Service as members.

The RAUSI Membership Committee grew by two members in 2010 to a total of 15. It now comprises of the following RAUSI members: Past Presidents Bruce Henwood, Sylvain Bouliane, Ken Sivertsen, Eric Haffenden, Dick Westbury, Bill

Wilson, and Lee Thompson; RAUSI Board Members President Bill Schultz, Vice President Ross Wickware, Directors Eric Cameron, Joanne Aylett and Gordon Leek; Canadian Forces representative LCol JJ Martin and RAUSI Member at large Jim Hennessy, and of course the RAUSI Secretary, Kim Nelson.

Membership in the Institute for 2010 was 257 members in all classes subdivided as follows: 152 Ordinary members (including Bursary winners and Memorial Cross recipients), 14 Out of town members, 26 Garrison members, 12 41 CBG members, 5 Corporate members, 38 Calgary Police Service members and 10 Life/Honorary members. This was down from 271 members in 2009, the noticeable difference being in fewer members from 41 CBG electing to become members of the Institute.

The Membership Committee met 7 times in 2010 to monitor membership numbers and discuss strategies in maintaining existing members and growing the membership base. The Membership Committee again recommended to the Board of Directors the continuance of the Earlybird membership renewal campaign that was started in 2008. There were prizes awarded to those members who renewed their membership for 2011 by 17 December 2010. This process resulted in 175 members renewing for 2011 or 68% early renewals, this reduces dramatically the Secretary's requirement to remind delinquent members.

As was done previously, the Committee set unofficial goals of 10% of the membership base for 2010, this equated to growing the membership by 27. However we did not make that, with just 11 new ordinary members joining in 2010. The membership goals for 2011 have been set at a more modest 15 new ordinary members. The outlook for 2011 is promising; all members of the Institute are encouraged to invite potential new members to the Mess and to attend the various RAUSI luncheons, speakers and special events.

Calgary Highlanders – 100 Years *By Captain Peter Boyle*

The Calgary Highlanders have completed a busy year of celebration and commemoration marking our Centennial. Along with the Centennial, the Regiment has had to concentrate on training and its continuing support to the mission in Afghanistan where 30 Highlanders have been deployed until the late spring.



January started with the traditional Robbie Burns dinner hosted by the Warrant Officers' and Sergeants' Mess. March brought the start of the busy spring with the ground breaking of the new Calgary Soldiers' Memorial which commemorates all of Calgary's Reserve Army soldiers killed-in-action since World War 1. Over 3000 Calgary Highlanders will have their names listed on this memorial. This was closely followed by the FTX Dinosaur Scout held from 19 to 21 March in the Drumheller area. The interesting geography of the "badlands" would make for challenging training for all members who attended and the support of 408 Tactical Helicopter Squadron was a welcome addition to the training. The 1st of April marked the 100th birthday of The Calgary Highlanders. The night before, the Regiment paraded at The Military Museums and a new temporary exhibit entitled "Tanks and Tartan" was unveiled celebrating the 100th anniversary of The King's Own Calgary Regiment and The Calgary Highlanders.

The busy tempo would continue into April with Exercise Domestic Ram on the weekend of the 17-18th. The following weekend was the 95th anniversary of The Battle of St. Julien. We marked this with our annual officers mess dinner and the Regiment exercising its Freedom of the City of Calgary. LGen Andrew Graham CBE was welcomed as the guest of honour for these events and it was wonderful to have the senior serving member of our Allied Regiment present to celebrate with us. The Mayor of Calgary, David Bronconnier, presented LGen Graham with a white cowboy hat, part of the city's traditional white hatting ceremony for distinguished guests and visitors.

The month of May would see the return of 30 soldiers who were deployed to Afghanistan for the preceding seven months. We are all happy to have them back in Calgary and we look forward to seeing the final few return home safely in the months to come. May would also see soldiers of the Regiment deployed for 10 days to Canada's North for Exercise Sovereign Grizzly in Yellowknife, Northwest Territories. This exercise challenged soldiers to perform infantry duties in very adverse conditions. This training would be immediately followed by Exercise Domestic Ram 2 held in Edmonton which would prepare the Regimental leadership for supporting tasks at home in the event of a domestic emergency.

Centennial celebrations continued with a large Centennial Parade held at Currie

Barracks on the 29th of May. Most would expect the 29th of May to bring beautiful spring weather and be ideal for a parade. However in Calgary, the 29th of May would bring snow and freezing temperatures which did not deter the Regiment parading before the new Lieutenant Governor – His Honour, Colonel (ret'd), The Honourable Donald Ethell, OC OMM AOE MSC CD.

Following the parade, we said goodbye to Honourary Colonel Bob Gibson CD. He has been associated with the Regiment for 20 years and will be missed for his expansive spirit, commitment and generosity. Honourary Lieutenant-Colonel Skip McDonald has recently been appointed in his place.

The Centennial parade was followed by a dinner held at The Military Museums where everyone could relax after a long day on the parade square. Sunday saw the end of the Centennial weekend with a picnic that was held inside Mewata Armoury due to the unseasonal weather!

Following the Centennial weekend, the Regiment had a single day to pause before many members embarked upon the Centennial Battlefield tour. This tour went from the 1st to 13th of June and saw over 80 members of the Regiment, the Pipes and Drums, Veterans and other members of the Regimental family tour significant battlefields around Northwest Europe. Plaques were unveiled in Normandy at Verrieres Ridge and Clair Tison (Both Battle Honours held by the Regiment in the liberation of Normandy). Other key sites visited were Juno Beach, the Somme battlefields, Vimy Ridge, the Ypres Salient and the areas in Holland that the Regiment liberated.

With the return from the Battlefield Tour, some members of the Regiment were entitled to a well deserved rest for a few weeks, while others headed off to attend or instruct on summer training courses. As well, the annual support to the Calgary Stampede kept many busy for the early part of July.

Other milestones which should be mentioned for the past few months include the production of a new recording by our Regimental Pipes and Drums. "Airghardt / Onward" is a 20-track CD that encompasses traditional music with some modern variations. The Regiment provided a guard for the visit of Her Highness, Princess Margriet of the Netherlands for the 65th Anniversary of Victory in Europe and the reopening of Central Memorial Park in Calgary. All of these events made for a very busy start to 2010.



The Fall of 2010 saw the beginning of the new training year, which included ranges and field training exercises. November saw the Regiment say farewell to its Commanding Officer, Lieutenant-Colonel Michael Vernon, who will be leaving the Regiment to go overseas on operations. Lieutenant-Colonel Mike Owens assumed command and will lead the Regiment into a new year of training and support to operations.

MINUTES OF THE 2009 ANNUAL GENERAL MEETING
HELD ON THURSDAY, 18 MARCH 2010
CALGARY GARRISON OFFICERS' MESS
COMMENCING AT 1900 HOURS

1. Call to Order

There were 24 Ordinary members, 4 Garrison members, 1 Memorial Cross member and 1 Life member registered. A quorum was declared in accordance with Article 41 of the bylaws. The meeting was called to order at 1913 with Lt(N) Bouliane in the Chair.

2. Invocation

Mr. Ron Semenoff called upon the members to rise while he blessed the members and board of the Royal Alberta United Services Institute. "Thank you Lord for your guidance and wisdom today and throughout the upcoming year. May you watch over us always, Amen".

3. Moment of Silence

Lt(N) Bouliane called upon the members to rise while he read the names of those RAUSI members who died during the past year; Captain Bill Finch, KOCR and Mr. Allan McKinnon. Lt(N) Bouliane also acknowledged the sacrifice and losses sustained by Canadian Forces in the War against terrorism in Afghanistan. One minute of silence was observed in their memory.

4. Welcome to RAUSI Members

Lt(N) Bouliane welcomed all members and guests to the AGM and thanked all for attending. He reported that this year we celebrate 90 Years, United in Service. Due to the fact that there are a lot of other ceremonies happening throughout 2010, RAUSI will host a celebratory ceremony later on in the year when most of the other ceremonies have happened. This year 2010 also marks the 100th Anniversary of the Canadian Navy, 100th Anniversary of the Calgary Highlanders and 100th Anniversary of the Kings Own Canadian Regiment. Lt(N) Bouliane also announced that 8 candidates were nominated for 5 vacancies on the board. The RAUSI membership keeps getting bigger and bigger and the board of directors is dedicated to moving forward.

5. Deputy Commander 41 Canadian Brigade Group (CBG)

LCol JJ Martin, Deputy Commander of the 41 CBG addressed the membership and offered his best wishes to the RAUSI and thanked them for inviting him to speak. Unfortunately Col Putts had another scheduled appointment and couldn't be present. Since April of 2009 the 41 CBG has been very busy. There was a Change of Command Parade for outgoing Col Wriedt for incoming Col Putt. The 41 CBG led Exercise Western Defender, joining 3 Western Brigade units; 38

CBG, 39 CBG and 41 CBG to join with 1 Canadian Mechanized Brigade Group in Edmonton. This was a training opportunity comprised of 2 important exercises, training and allowing reserve soldiers to operate equipment and vehicles regularly used in Afghanistan.

In August 2009, the Yellowknife Infantry Company was formed and will be directed through the Loyal Edmonton Regiment, a 41 CBG infantry unit based in Edmonton, Alberta. It represents the first army unit to be manned and stationed in the North West Territories and is currently the only active army reserve unit north of 60. The company will focus its training in order to operate in the harsh Arctic environment of northern Canada in support of other CF formations. This is not a full time regular force army unit, but rather a unit comprised of both part time and full time reservists. Recruitment will be drawn locally from Yellowknife and surrounding area.

December 2009 was a sad dark day as we lost 2 soldiers from Calgary and 5 others were injured in the war in Afghanistan. May they rest in peace.

As mentioned earlier by the President Lt(N) Bouliane, 2010 is becoming very busy as they are preparing for centennials; The Canadian Navy, Calgary Highlanders and Kings Own Calgary Regiment. LCol Martin asked that we keep May 28th and May 29th open, as it is a celebratory weekend.

6. Don Freeman Memorial Bursary/
Queen Elizabeth II Golden Jubilee Bursary

On behalf of the Bursary Committee chaired by Rev Haffenden, it was announced that both bursaries were awarded on May 31st, 2009. The Royal Alberta United Services Institute annually offers two Bursaries for post secondary study. Each bursary is worth \$1,000. Applicants must provide proof of actual enrollment in a post secondary institution.

The Wing Commander Don Freeman Memorial Bursary for 2009 was awarded to Coxswain Nicole Parson-Admussen, Royal Canadian Sea Cadet Corps, Calgary (RCSCC Calgary). Nicole is studying for a Bachelor of Arts at The University of Calgary, Faculty of Social Science, majoring in history. She volunteered with the cadet poppy drive and also volunteers at The Military Museums. We wish her well in all of her endeavors.

The Queen Elizabeth II Golden Jubilee Bursary for 2009 was awarded to Private Matthew Churchill, Reserve Unit – Calgary Highlanders. Matthew is studying Criminal Justice at Mount Royal University. He has served in the cadets, reaching the level of Chief Warrant Officer/Regimental Sergeant Major, attended the Leadership course at Vernon in 2006, took part in the Maple Leaf Exchange in 2008, placed second in Alberta in the National Star Certification Exam, and was

awarded the Gorget Award for 2009. We wish him well with his studies and future career.

Reverend Haffenden also reported that both Bursaries will now be worth \$5,000.00 thanks to the Alberta Gaming and Liquor Control funds. The Board and the Institute congratulate both of these fine young people.

Monies raised in 2009 from the race were approximately \$58,000.00. The purpose of the Foundation is to benefit the community as a whole by promoting and supporting non-government funded programs, events and services related to; Canadian Forces Regular and Reserve Units; Military Families; Veteran Well Being and Care Facilities, and Remembrance of the Fallen, just to name a few. This year's race for the Loops for the Troops will be held on Fathers' Day, 21 June 2010, at North Glenmore Park. The campaign is in full motion.

11. CGOM Report

LCol Schultz reported that negotiations with the President of the Mess Committee, Major MacLaine, and the Commanding Officer of ASU, Major Tremblay, the Commander of 41 Brigade and himself are ongoing. They have met approximately twice since the New Year and talks are going well. We hope to have a written understanding in the near future. 18. Other Business

Lt(N) Sylvain Bouliane sadly reported that he will have to step down as President. He apologized for any inconvenience this might cause. Due his already heavy workload which is rapidly increasing he cannot commit the time and energy to lead the Board of Directors of the Institute. It is clear to him that the Board is presently made up of very dedicated and hard working Directors. As other members seem to have more time on their hands, he would like to pass on the torch to the next best candidate, though he will continue to serve as Past President. Until the next board meeting, 14 April 2010, he has asked Vice-President LCol Schultz to act as President, which he accepted. A large round of applause was given to Lt(N) Bouliane.

LCol Martin stood and addressed the AGM. He reported that he was very sad to see Lt(N) Bouliane resign but congratulated him on recognizing that he could not commit the time. On that note, there is now a vacancy on the Board. How will that be filled?

Maj Sivertsen reported that the Board will vote at the next meeting, 14 April for both President and Vice President. They will then ask the 3 non-elected candidates if they would like their names to stand for election. Whatever is decided, it is the Board's decision.

19. Adjournment

1. Purpose of the organization:

The Royal Alberta United Services Institute (the "Institute") was incorporated in accordance with the Societies Act of Alberta and is one of 27 United Services Institutes in Canada.

The general purpose of the Institute is to promote, support and foster Canada's military forces. This is sought through various activities including the provision of financial and moral support to Alberta's militia and cadet corps, seeking to promote and encourage public awareness for Canada's military establishment and making grants for the maintenance of various militia organizations.

The Institute is a not-for-profit organization under Section 149(1) of the Income Tax Act and accordingly, is not subject to income tax.

2. Significant accounting policies:

Management has prepared the Institute's financial statements in accordance with accounting principles generally accepted in Canada, which require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingencies at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Significant areas requiring the use of management estimates relate to the valuation allowance for accounts receivable and the useful life of property and equipment for depreciation purposes and evaluation of their net recoverable amount. Consequently, actual results could differ from these estimates. In management's opinion, the financial statements have been properly prepared within the framework of the significant accounting policies summarized below.

(a) Basis of accounting:

The Institute maintains its accounts using the accrual basis of accounting.

(b) Cash and restricted cash:

Restricted cash includes cash on deposit and term deposits with original maturities of less than three months.

(c) Merchandise:

Merchandise is recorded at the lower of cost or net realizable value on a specific item basis.

2. Significant accounting policies (continued):

(d) Property and equipment:

Property and equipment is recorded at cost. Donated property and equipment is recognized at fair market value when fair market value at date of contribution can be reasonably estimated. Depreciation is recorded using the straight-line method over the estimated lives of the assets as follows:

Facility improvements	10 years
Furniture and equipment	5 years

(e) Revenue recognition:

The Institute follows the deferral method of accounting for contributions, which includes membership fees. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred.

Unrestricted contributions, such as casino proceeds, that are not designated for a specific purpose, are recognized as revenue when received and the event is completed. The casino proceeds are used for donations, bursaries and operational purposes, as specified by the Alberta Gaming and Liquor Commission and as approved by the Board of Directors.

Revenue is recognized when collection is reasonably assured.

(f) Donated materials and services:

Donations in kind are recorded in the financial statements at fair market value when fair market value can be reasonably estimated. Volunteers contribute substantial donated time and services to assist the Institute in carrying out activities. Because of the difficulty of determining fair market value of these donated services, they are not recorded in these financial statements.

Revenue associated with capital-in-kind asset donations is recognized as donations revenue in amounts that equal the annual depreciation of the capital in-kind asset contribution.

2. Significant accounting policies (continued):

(g) Financial instruments:

All financial instruments are initially recognized at fair value on the balance sheet date. The Institute has classified each financial instrument into the following categories; held for trading financial assets and liabilities, loans or receivables, held to maturity investments, available for sale financial assets, and other financial liabilities. Subsequent measurement of the financial instruments is based on their classification. Unrealized gains and losses on held for trading financial instruments are recognized in earnings. Gains and losses on available for sale financial assets are recognized in changes in net assets and transferred to earnings when the asset is derecognized. The other categories of financial instruments are recognized at amortized costs using the effective interest rate method.

The Institute has classified cash, restricted cash and investments as held for trading, accounts receivable as loans and receivables, and prepaid membership fees as other liabilities.

(h) Comparative figures:

Certain of comparative figures have been reclassified to conform to the presentation in the current year.

3. Financial instruments:

(a) Fair value of financial assets and financial liabilities:

Financial instruments include cash, restricted cash, accounts receivable and prepaid membership dues which approximate their carrying value because of the short term nature of these instruments.

Investments are recorded at the fair values.

(b) Foreign currency risk:

The Institute is not exposed to foreign currency fluctuations.

3. Financial instruments (continued):

(c) The Institute has exposure to the following risks from its use of financial instruments:

(i) Credit risk:

The Institute's exposure to credit risk is on accounts receivable.

Credit risk relates to the possibility that a loss may occur from the failure of another party to perform according to the terms of a contract. Cash and restricted cash represent bank balances with a Canadian commercial bank. Credit risk for accounts receivable is the risk that the obligation will fail to be discharged causing the Institute to incur a financial loss. Credit risk is minimized by ensuring that cash and restricted cash is limited to amounts covered by insurance limits and that credit is only extended to those entities that management believes has the financial capacity to pay obligations due to the Institute.

(ii) Liquidity risk:

Liquidity is the risk that the Institute will encounter difficulty in raising membership fees to meet commitments associated with financial instruments. Management controls liquidity risk through cash flow projections used to forecast funding requirements for its financial instruments.

(iii) Market risk:

Current and future investments are subject to market risk due to changes in the value of investments. Fluctuations in general market interest rates have an impact on investments returns in the restricted cash.

4. Restricted cash:

Restricted cash is comprised of funds received through casino fund raisers. This restricted cash may only be used for activities authorized with the original casino application which includes donations, bursaries and operational purposes.

5. Investments:

The investments are recorded at market value and consist of a brokerage house account invested in fixed income equities and various provincial bonds which are fair valued at year end.

7. Internally restricted net assets:

The building reserve fund was created to provide financial security to the Institute by providing a source of funds for such capital items as may be required from time to time. The monies may be used only upon approval of the Board of Directors.

The facilities enhancement fund was created to be used for the acquisition of property and equipment used in the refurbishment of the Mewata Officers Mess. The monies may be used only upon approval of the Board of Directors.

8. Capital management:

The Institute's objectives, policies and processes for managing capital include maximizing interest and investment income earned on excess cash proceeds. All revenue is deposited in the general account and excess funds in investments and term deposits. The Institute does not have any externally imposed capital requirements.
