

TAIWAN OUT THERE...

## ADRIFT ON A SEA OF UNCERTAINTY

Nanaimo: 18 February 2019: as island maps go, Taiwan looks like almost any other island; indeed, rejiggered, Vancouver Island could be dropped in as a near twin...well, that may be stretching it just a bit; there are some fairly striking differences. Taiwan is approximately 36,000 square km in size, compared to Vancouver Island's 33,000 square km. The population differential is much more remarkable; about 24 million people live on Taiwan, while only

780, 000 live here on our Island. The UN ranks Taiwan as the 23<sup>nd</sup> richest country in the World, while the IMF ranks Taiwan at 19<sup>th</sup> with a per capita GDP of \$US 52,100 while Canada only ranks 24<sup>th</sup> with per capita GDP \$US 49,775. I'm a little suspicious of those stats, but they're what I've got "off-line!"

However, on another scale, the homicide rate in Taiwan is about twice

Canada's, and, you're twice as likely to be locked up in Taiwan as you would be here. And, on still another scale, the spread between rich and the





poor is very much more evident on Taiwan. There, the rich are very, very rich, while the poor are very much-so.

However, Taiwan, well relatively prosperous, lives on borrowed time. In 1971, the UN bounced Taiwan from both the General Assembly and the more-exclusive Security Council, doing so in favour of the People's Republic of China (PRC). The merits of some realistic representational change were evident at the time, but Taiwan has

since become increasingly isolated on the global stage. Most countries, Canada included, accept the PRC claim that Taiwan is a rebellious, yet-to-be absorbed or re-absorbed province of mainland China.

About 3% of Taiwan's populace is indigenous, with roots dating back to about 10,000 BCE. The population otherwise is largely of Chinese origin. Taiwan is also a natural extension of the chain of islands that make up Japan's Okinawa Prefecture. Japan's Yonagni Island is only about 60 km NW of Taiwan, although Japan acknowledges that Taiwan is part of China. Successive PRC Chairmen (presidents) have been clear that Taiwan will become a vassal province of China by NLT 2049, that year marking the hundredth anniversary of the establishment of a Chinese Communist government on the mainland. Actual occupation of Taiwan, if successful, would also reinforce growing PRC claims to and occupation of other China Seas islands and islets, almost all of which are, historically, not Chinese.

And, there's "the rub!" With the annexation of Taiwan, China's strategic reach out into the Philippine Sea and the West Pacific Ocean will be *fait accompli*. More-so than is now the case, Japan and the Philippines will be well within China's sphere of interest. Equally telling and possibly worse for other South East Asian maritime states, the China Seas will be *de facto* Chinese inland waters.

Which leads me to the obvious question. How will China achieve its 2049 unification goal with Taiwan?

For now, it seems probable that the Taiwanese will resist occupation. A Chinese version of *anschluss* would only be welcomed by a small minority of Taiwanese; about 15% at the



most, this on the basis of a December 2018 survey. Given China's growing influence with Asian, African and other members of the UN's General Assembly, and, with an assured veto in at the Se-

## **LUNCHEON MEETING ATTENDANCE**



curity Council, the UN will do nothing should war over Taiwan actually occur and invasion follow. Indeed, the UN may well call such a war to be a civil one for resolution by the "Chinese peoples" alone. Self-determination by and for the Taiwanese won't be in the cards. Like Tibet before it, Taiwan would disappear behind the Bamboo Curtain.

Among the current crop of backyard bullies that so dominate the world scene, China is the new "Mr. Big." Front and centre, China respects & uses strength and is contemptuous of weakness. That's why they spit in our eye over the Meng Affair. That's why they occupy Tibet.

So; how will it all end? How indeed? Here, I suspect Canadians here will be treated to a succession of town-hall meetings, featuring contemporary versions of Chamberlain's speech:" how horrible, fantastic, incredible it is that we should be digging trenches and trying on gas masks here because of a quarrel in a far-away country between people of whom we know nothing."

Could and should Canada be doing more and something different in our Asian relations? You bet! We'll have to first wait-out the Meng Affair, but then we need to rebalance our relationships with China. The 5G impasse must be resolved with more courage than the Government has shown to date. Huawei should get the boot "in the National Interest!" For starters too, China's diplomatic staff here should be progressively cut by at least a half over a period of not more than six months. Next, in just one year, imports from China, which currently are about three times what they buy from us, should be frozen so that imports more closely match exports, dollar for dollar. Then, other than for accredited diplomats, visas for Chinese nationals should be limited to a sixmonth duration, with no extensions. Oh, Canada's vested interests will howl at all this, but it's opportune to make our national mark forcefully. And, Taiwan? Well, let us at least improve our existing relations there...socially & economically. Politically, Taiwan will need to do more for themselves...just maybe with a little help from their

friends, there's still hope.
