# HAY DAYS FOR CHINA

Nanaimo, 25 March 2019...I've been leafing back through old Musing Columns, confirming that I've become a bit of a bore & a nag when it comes to the People's Republic of China. I have & I am, but I think I have sound grounds for my concerns. My own collection of columns is incomplete, but I count eight columns, in just the last seven years, about Red Chinese lurking under our beds! If all comes off as expected, our next Featured Speaker will be much sharing some

"contemporary first-hands on" thoughts than are my own on our important vulnerable interests out at the western reaches of the Pacific Ocean. Back in April 2013 I suggested that China has "just about" settled its declared land claims on Mainland Asia. The principal remaining irritant is with India over the previously independent Buddhist Kingdom of Bhutan. China's interests there rest in the claim that the now-republican Bhutan is an

"unrecovered" part of Tibet. For India, Chinese continued ambitions over Bhutan compounds the threats to India's vulnerable 14-mile-wide land link to Eastern India, with the latter penned in by Nepal, Chinese Tibet, Bhutan and Bangladesh. Of course, the real stake in all of this may be found in the icefields of the Himalayas, which are a vital source for fresh water for much of South-East Asia

However, aside from this ongoing Himalayan dispute with India, China's real territorial aspirations are to be found in the China Seas. Members will remember the now notorious "nine-dash line



boundary" drawn by China to delineate Chinese national waters in the China Seas. While the International Court of Justice ruled in 2016 that China was abridging & violating the rights of the Philippines to the latter's national waters, China simply "go-to-hell-like" denies that decision to be enforceable.

The so-called Law-of-the-Seas is based on the simple premise that any ship shall the right of peaceful passage on the High Seas as opposed to managed passage through Territorial Waters. The "reach out-to-sea" to differentiate between the two was originally set at the length of a canon shot, then set over the years progressively at one, three

and currently twelve nautical miles.

Even this is complexed by exceptions for exclusive or shared fishing or economic rights and zones.

In the face of almost universal condemnation,



China has gone ahead with the clearance of other nationals from waters, islands, islets, reefs and simple promontories in what the Chinese claim to be their territorial waters. China has declined to submit other claimant objections to arbitration, but has offered to settle disputes directly, *mano a mano* without any outside "interference." Over the course of the half dozen years, China has already consolidated its occupation of the Gulf of Tonkin's Parcel Islands, having forcibly displaced

Vietnamese from the Islands years earlier.

Meanwhile, China's infrastructure constructions continue apace on a number of naval and military bases on "recovered land" in the South China Sea. Four airfields have either already been constructed or are under constructed or are under construction, with warships and combat aircraft deployments also already underway. In a very

practical way and sense, China is successfully redefining the range of canon shot in 21<sup>st</sup> Century terms, all to China's satisfaction. Realpolitik, Force Majeure, and patience are carrying the day.

# **LUNCHEON MEETING ATTENDANCE**


